



The life-changing event for Oles happened when he saw a homeless man, on a cold winter's night in one of the local Connecticut shelters, give up his bed to a homeless woman. Later, Oles, with another homeless person, spoke to students at a local school about homelessness. The students were inspired to take action, raising money for the homeless person to get **off the streets**. The students' generosity and energy inspired Oles to form **Off The Streets**.

Homelessness is closer than we think and can occur at any time as well as for a variety of reasons. Various statistics show that millions of Americans live paycheck to paycheck and that many are unprepared for an unexpected expense.

Deacon Kevin Moore founded the **Off The Streets (OTS)** chapter in the greater Bridgeport area in 2014. He was dedicated to helping those in need and treasured the work he did in helping secure homes for those experiencing homelessness. His quiet manner, genuine concern, and ready smile reassured both clients and staff.

Kevin continued his ministry until his death in June 2019, helping over 250 men, women and children get into homes of their own. The **Off The Streets** ministry continues to serve God's people in the spirit of Deacon Kevin under the leadership of Gerard Agoglia. Our placement numbers grow monthly as we assist those in need with a security deposit of approximately \$335 per person. Thanks to the generosity of people like you, we are helping more and more individuals get **Off The Streets**.

Deacon Kevin Moore Memorial Fund

In honor of Kevin's vision of working to end homelessness, **OTS Bridgeport** is pleased to announce the establishment of the **Kevin Moore Founder's Memorial Fund**. This fund represents a special opportunity to pay tribute to Kevin's goal of giving back hope to those in need in Greater Fairfield County community.

Our goal for the Memorial Fund is to build an investment portfolio of sufficient magnitude so that the earnings will provide sustaining revenue to support our mission of placing those experiencing homelessness into apartments.

Off the Streets Bridgeport is an all-volunteer, 501(C)(3) charitable organization. All donations are fully tax-deductible (EIN: 27-0979787). The organization funds its operations from private donations, no government funds are involved. Approximately 95% of all donations fund security deposits on behalf of the homeless.
